2025 O'ahu County Democrats Election & Nomination Rules from the Bylaws of the O'ahu County Democrats

Section 2. Executive Committee

(2.11) Election of Executive Committee. With the exception of the Chair and Vice Chair and Regional Chairpersons, each member of the Executive Committee shall be elected by a majority of the votes cast at the Oʻahu County Convention in odd-numbered years. The Chair and Vice Chair will run on a combined slate and shall be elected at the same convention by a majority vote cast for the combined slate. The Regional Chairpersons shall be elected at the same convention by a majority of votes cast in their respective regions.

Section 5. Eligibility.

(5.1) Eligibility. Any member of the Party residing in the County may be elected an officer of the County Committee including County Chairperson, with the requirement that any member seeking the office of County Chairperson shall have been a member of the Party for at least one (1) year prior to the County Committee Officers election. Election to the positions of Chair and Vice Chair shall be combined as a slate with two different genders, so as to assure diversity in these leadership positions. They will be voted upon as one slate. Elected officials, individuals appointed to fill an elected office, or candidates for elected office are not eligible to become County Chairperson. If a member has resigned from the Party in the two years prior to re-enrollment, the re-enrolled member must be a member in good standing for at least one year prior to the County Committee Officers election prior to being elected an officer of the County Committee.

If any District Council member is elected as a County officer, that person shall automatically vacate the lesser office. Any person who wishes to be a candidate for OCC Chairperson, Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer or Regional Chairperson shall file nomination papers at least ten (10) days prior to the County Convention.

The nomination papers shall be signed by not less than five (5) members of the Democratic Party of Hawai'i residing in the O'ahu County or Region being represented. Electronic Signatures are permissible.

(5.2) Elections. Election(s) shall be decided by a majority of votes cast by roll call at a County Committee meeting if conducted by teleconference or video conference, or by mail balloting if provided for as part of an electronic convention. Elections conducted by ballot may be decided by ranked-choice voting. All ballots must be signed ballots. If there is only one nominee for a particular position that nominee shall be elected by acclamation. Each region shall have separate ballots or electronic voting to elect Regional Chairs where more than one candidate is running for the same position. Unless ballot voting provides for ranked-choice voting, if no candidate receives a majority on the first ballot or roll call vote, then a second ballot or roll call vote between the top two vote-getters shall be conducted. Subsequent ties shall be decided by the flip of a coin.

Candidates must have filed nomination papers with the county secretary or chair by 4:30 pm April 30 . Nominations shall not be accepted from the floor.

Rule 11. Elections.

At the 2025 Convention, elections will be held for the O'ahu County Chairperson and Vice Chairperson slate, County Secretary, County Assistant Secretary, County Treasurer, County Assistant Treasurer, and Ten (10) Regional Chairpersons. The election shall be decided by a majority of votes cast.

- A. Election shall be by an electronic poll (iClicker) or signed ballot unless there is only one (1) nominee for a position in which case election shall be by acclamation.
- B. In contested races, candidates may speak for two (2) minutes each. Delegates shall elect candidates for contested positions using a single, first poll or signed ballot provided
- C. The election shall be decided by a majority of votes cast. If no candidate receives a majority on the first poll, then a second poll or signed ballot between the top two (2) vote-getters shall be conducted.
- D. Ties on the second poll or ballot shall be decided by the flip of a coin.
